

## **PREDETERMINED INCREASE**

### **CRAFT/CLASSIFICATIONS:**

Electrical Utility Lineman (Lineman, Cable Splicer, Powderman, Groundman)

### **DETERMINATION:**

C-61-X-3-2024-2

### **LOCALITIES:**

All localities within the State of California except Del Norte, Modoc, and Siskiyou Counties

This predetermined increase for the above-named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2024, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (\*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (\*\*) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

### **ELECTRICAL UTILITY LINEMAN: LINEMAN, CABLE SPLICER**

Determination C-61-X-3-2024-2 is currently in effect and expires on December 31, 2024.\*\*

Effective January 1, 2025, there will be an increase of \$0.12 allocated as follows: \$0.25 increase to Health and Welfare and \$0.13 decrease to Pension.

Effective June 1, 2025, there will be an increase of \$2.70 allocated as follows: \$2.10 to the Basic Hourly Rate, \$0.10 to Health and Welfare, and \$0.50 to Pension.

Effective June 1, 2026, there will be an increase of \$2.77 allocated as follows: \$2.17 to the Basic Hourly Rate, \$0.10 to Health and Welfare, and \$0.50 to Pension.

There are no further increases applicable to this determination.

### **ELECTRICAL UTILITY LINEMAN: POWDERMAN**

Determination C-61-X-3-2024-2 is currently in effect and expires on December 31, 2024.\*\*

Effective January 1, 2025, there will be an increase of \$0.12 allocated as follows: \$0.25 increase to Health and Welfare and \$0.13 decrease to Pension.

Effective June 1, 2025, there will be an increase of \$1.44 allocated as follows: \$1.34 to the Basic Hourly Rate, and \$0.10 to Health and Welfare.

Effective June 1, 2026, there will be an increase of \$1.32 allocated as follows: \$1.22 to the Basic Hourly Rate, and \$0.10 to Health and Welfare.

There are no further increases applicable to this determination.

## **ELECTRICAL UTILITY LINEMAN: GROUNDMAN**

Determination C-61-X-3-2024-2 is currently in effect and expires on December 31, 2024.\*\*

Effective January 1, 2025, there will be an increase of \$0.12 allocated as follows: \$0.25 increase to Health and Welfare and \$0.13 decrease to Pension.

Effective June 1, 2025, there will be an increase of \$1.02 allocated as follows: \$0.92 to the Basic Hourly Rate, and \$0.10 to Health and Welfare.

Effective June 1, 2026, there will be an increase of \$0.93 allocated as follows: \$0.83 to the Basic Hourly Rate, and \$0.10 to Health and Welfare.

There are no further increases applicable to this determination.
