LOCALITIES:

All localities within Del Norte, Modoc, and Siskiyou counties.

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2024, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. Determination C-61-X-8-2024-1 is currently in effect and expires on December 31, 2024**.

LINEMAN, HEAVY LINE EQUIPMENT MAN, CERTIFIED LINEMAN WELDER, POLE SPRAYER

Effective January 1, 2025, there will be an increase of \$0.25 to Health & Welfare.

Effective February 1, 2025, there will be an increase of \$4.21 to be allocated as follows: \$3.21 to Basic Hourly Rate, \$0.10 to Health and Welfare, \$0.84 to Pension, \$0.05 to Training, and \$0.01 to Other.

Effective February 1, 2026, there will be an increase of \$4.48 to be allocated as follows: \$3.37 to Basic Hourly Rate, \$0.10 to Health and Welfare, \$0.95 to Pension, \$0.05 to Training, and \$0.01 to Other.

Effective February 1, 2027, there will be an increase of \$6.42 to be allocated as follows: \$4.60 to Basic Hourly Rate, \$0.10 to Health and Welfare, \$1.64 to Pension, \$0.07 to Training, and \$0.01 to Other.

Effective February 1, 2026, there will be an increase of \$3.61 to be allocated as follows: \$3.13 to Basic Hourly Rate, \$0.10 to Health and Welfare, \$0.34 to Pension, and \$0.04 to Training.

Effective February 1, 2027, there will be an increase of \$4.82 to be allocated as follows: \$4.26 to Basic Hourly Rate, \$0.10 to Health and Welfare, \$0.38 to Pension, \$0.07 to Training, and \$0.01 to Other.

Effective February 1, 2028, there will be an increase of \$5.12 to be allocated as follows: \$4.55 to Basic Hourly Rate, \$0.10 to Health and Welfare, \$0.38 to Pension, \$0.07 to Training, and \$0.02 to Other.
