**IMPORTANT NOTICE TO AWARDING BODIES AND ALL INTERESTED PARTIES
REGARDING A MODIFICATION TO
THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS**

Dear Public Official/Other Interested Parties:

CRAFT/CLASSIFICATION: Plumber: Landscape/Irrigation Fitter (All Shifts)

LOCALITIES: All localities within Imperial, Inyo, Kern, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara and Ventura Counties

DETERMINATIONS: IMP-2026-1, INY-2026-1, KER-2026-1, LOS-2026-1, MON-2026-1, ORA-2026-1, RIV-2026-1, SBR-2026-1, SDI-2026-1, SLO-2026-1, STB-2026-1, and VEN-2026-1

The predetermined increase of \$4.03 scheduled to take effect on September 1, 2026 for the above mentioned craft/classification has been reduced; the correct predetermined increase amount and allocation are listed below:

Effective September 1, 2026, there will be an increase of \$4.00 allocated as follows: \$3.10 to the Basic Hourly Rate, \$0.75 to Health & Welfare, \$0.05 to Pension, \$0.05 to Training, and \$0.05 to Other payments.

With the exception of the above modification, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.

CRAFT/CLASSIFICATION: Plumber: Landscape/Irrigation Tradesman (All Shifts)

LOCALITIES: All localities within Imperial, Inyo, Kern, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara and Ventura Counties

DETERMINATIONS: IMP-2026-1, INY-2026-1, KER-2026-1, LOS-2026-1, MON-2026-1, ORA-2026-1, RIV-2026-1, SBR-2026-1, SDI-2026-1, SLO-2026-1, STB-2026-1, and VEN-2026-1

The predetermined increase of \$2.07 scheduled to take effect on September 1, 2026 for the above mentioned craft/classification has been reduced; the correct predetermined increase amount and allocation are listed below:

Effective September 1, 2026, there will be an increase of \$0.57 allocated as follows: \$0.52 to the Basic Hourly Rate and \$0.05 to Other payments.

With the exception of the above modification, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
