Subject: Proposed Amendments for Title 8, California Code of Regulations, General Industry Safety Orders, Article 152, Diving Operations.

You are invited to participate in an advisory committee to be convened by the Occupational Safety and Health Standards Board (Board) staff as a follow-up to previously adopted federal amendments regarding commercial diving operations. The advisory committee will consider proposed amendments to Sections 6051, 6056, and 6057 regarding requirements for technical diving operations.

On November 28, 2017, amendments to California's diving regulations became effective. The amendments were made using the expedited HORCHER process in response to an email from federal OSHA, which detailed several instances where California diving regulations were less protective than the corresponding federal regulation.

As a result of public comment, some of the originally proposed changes were removed from the HORCHER proposal to await further discussion in an advisory committee setting. Additionally, some of the changes requested by OSHA were deemed by Board staff as inappropriate for amendment using the HORCHER process.

The purpose of the advisory committee will be to discuss the remainder of the changes requested by OSHA concerning California's diving regulations. The advisory committee will be held at the following time and location (please park in the back lot):
