Regardless of immigration status,

CA PERMANENT PAID SICK LEAVE

You may be entitled to 5 days (40 hours) of paid sick time per year. You qualify if you work at least 30 days in CA in a year and 90 days on the job. This is for full-time, part-time, and temporary workers.

You may have the right to paid medical treatment and partial replacement of wages lost for a work-related injury or illness.

You have the right to a safe workplace free of health hazards, including COVID-19. Your employer must have a written COVID-19 prevention program, and must provide the training and tools necessary to keep you safe.
