- Commissioner Goff stated that the new administration has signed an executive order. He stated there has be a new bipartisan apprenticeship bill that was introduced to the Senate on June 24, 2017. He stated that it talks about tax credits up to \$3.00 per hour for those that employ apprentices. He stated that will be something to continue to watch.
- Commissioner Goff stated that if anyone has any suggestions regarding how to better market apprenticeship please forward along the information. Also if you have suggestions on Marketing to new program sponsors.
- Tess Gormly, DAS discussed the current partnership that DAS has with BusinessU. She stated that DAS is hoping to put together a 2-minute video to put on our website to help market and advertise apprenticeship. She stated that they are hoping to have the contract finalized with BusinessU within the next 4 weeks. Once the contract is completed, they are hoping to have additional consultant training sessions to help provide additional tools on business outreach for apprenticeship.

 community.
