Updates:

I am pleased to announce Adele Burnes, Deputy Chief, will join Glen Forman and me on our DAS executive team. Adele started on October 1, 2021 and will be a key leader in developing our strategic plan to create 500,000 new apprentices over the next decade. The DAS management team has made some additional hires as well. Please join me in welcoming Adele and our new team members to the DAS team.

On September 14, 2021, the California Apprenticeship Council Chairperson Christopher Christophersen Sr. called a special meeting of the California Apprenticeship Council to discuss pending litigation per Government Code § 11125.4. The meeting discussed two lawsuits below. The DAS expects additional lawsuits to be filed.

The DAS launched its Tableau feature to internal staff last quarter and is now allowing the public to access our dashboards on the Tableau Public website. This can be accessed from our website or directly at https://public.tableau.com/app/profile/california.apprenticeship. This allows DAS to easily capture California Apprenticeship System data in formats that include heat maps, pie charts and bar graphs. DAS is working on providing a solution to put Tableau data on the web for public use. Deputy Chief Glen Forman is working with DIR's information technology team.

Field Office Activities

Our six field offices consultants continue to service our existing JACs, UACs and other program sponsors – attend your committee meetings, help on program revisions, annual self-assessments, audit/evaluation report compliance, apprentice disciplinary issues, public works compliance and any other advice and assistance you may need to continue the successful operation of your apprenticeship programs. Numerous committee reassignments continue to take place and we expect more reassignments to equalize workload and services.

Under direction of California Human Resources, we have updated our interview and selection procedures for hiring staff to fill the open positions throughout the state. We are still experiencing retirements in most of our districts we are working to fill all our vacant positions as quickly as possible.

We have interviewed twelve applicants for jobs in two offices and are posting more positions, please continue to send/ apply! We hope that the personal unit will clear our top scoring applicants so we can hire them for both Southern California & Northern California very soon. Please keep encouraging qualified apprenticeship folks to apply!

Apprenticeship Training Fund Check Processing

New Programs:

No new programs for the past quarter

Federal Grant

In July 2020, DAS was awarded a federal Technology grant in the amount of \$450,000. This grant has been used to enhance DAS ability to identify and implement specific technical assistance (TA) strategies that has changed existing and created new effective processes and/or services, in the delivery of TA to sponsors for the purposes of increasing efficiency, improving overall impact, and removing barriers in expanding Registered Apprentice Programs (RAPs). The grant funding has been used to enhance the DAS reporting systems with the introduction of Tableau, a business data visualization software that permits DAS to create reports using visual representations of the apprenticeship data collected from the DAS California Apprenticeship System (CAS) database. This funding allows DAS to better capture and represent demographic data across all workforce sectors and provide requested reports to the CAC and its members that were not readily available before the recent enhancements to the DAS CAS database system.

On July 1, 2021, DAS was awarded a \$10 million State Apprenticeship Expansion, Equity, and Innovation Grant (SAEEI) grant. This grant will deliver at least 1,500 new apprentices with diversity, inclusion, and equity as a key strategy. The equity goals include serving at least 60% people of color, 40% women, and 10% people with disabilities and justice-involved. The DAS shall use the SAEEI funding to contract with at least four Regional Local Workforce Development Boards (Local Boards) to develop and operate multi-employer apprenticeships. The Local Boards may contract with apprenticeship intermediaries to help the program sponsor administer the program, provide outreach services to help the expansion efforts in targeted industries, recruit under-represented populations such as women, people of color, veterans, justice-involved, people with disabilities, youth, and the multitude of unemployed due to the COVID-19 pandemic. The Local Boards' focus will be to promote diversity, equity, and inclusion. DAs plans to release the Solicitation for Proposals (SFP) in October 2021 and shall announce the successful grantee applicants on or about the end of December 2021.

The active apprentices numbered **75,819** / **91,349**

New registrations and reinstatements numbered 6,969 / 8,852 for the quarter.

Minorities represented **68.7%** / **69.8%** of all active apprentices.

Active women apprentices numbered **2,490** / **6,647**, which is **3.3%** / **7.3%** of all active apprentices.

There are currently 8,985 / 8,985 veterans active, 3,224 / 3,547 of which registered and 2,249 / 2,449 completed in 2021.

Program Evaluations July 1, 2021 through September 30, 2021

Since July 1, 2021, DAS opened seven (7) apprenticeship program evaluations. Six (6) program evaluation are still in progress, and there are ten (10) programs with corrective action needed (eight (8) opened in 2019 and two (2) opened in 2020). DAS field consultants are monitoring these programs to ensure their recommendations are completed.

DAS will continue to send new evaluation notification letters when programs reach their first year anniversary date or make substantial revisions, fall below the 50% industry graduation rate, and when programs have two or more meritorious complaints filed against them within a five (5) year period. To ensure high-quality apprenticeship administration, field consultants will assist programs with correcting the deficiencies found in order to close their evaluations/reviews.
