II. APPROVAL OF MINUTES

A motion and a second for approval of the July 28, 2021 meeting minutes. All approved.

III. OLD BUSINESS

- Review of proposed regulations AB 2358 and CalPlan for submittal to the full Council.

We reviewed of proposed regulations AB 2358 and CalPlan for submittal to the full Council. This item we have been working on over the last year.

A motion and a second for approval to send to the proposed regulations AB 2358 and CalPlan to the CAC. All approved. The motion carried.

Originally we had asked for an opinion from the state attorney general's office to review the CalPlan. We did receive a opinion from the AG office. Commissioner Buckhorn stated that it appears that the CalPlan is no longer necessary and that we can remove it from Title 8 section 201 and 215. After going through this that is exactly what we have been focused on. Glen stated that at the last meeting we amended the CalPlan section 215 to basically say California Plan for Equal Opportunity in Apprenticeship and just put the selection procedures in that part of the statute. That was the only thing that was missing from the original CalPlan that needed to be dealt with.

Questions and Comments from the Public.

Discussion on the CalPlan noting that it was amended rather than deleted. Discussion and comments on Economic Impact of AB 2358 proposed regulations.

reported that the committee had spent the last year meeting on a monthly basis to prepare the proposed rulemaking package that has been posted on the DAS Website Meetings Page right after our last meeting earlier this month, At this time we are submitting the Rulemaking Revisions and additions for AB 2358 including amendments to the Section 215 (CalPlan) to the full committee for approval at tomorrow's meeting.

The motion was brought forth again to this committee.

A motion and a second for approval to send to the proposed regulations AB 2358 and CalPlan to the CAC. All approved. The motion carried.

- Comments on Economic Impact of AB 2358 proposed regulations

Glen stated that he needed more information from programs to do this analysis and come back to this committee with some recommendations for fiscal impact. At this time not enough information has been received to determine.

The question was asked. How much is it going to cost you as a program to comply with the requirements, notices, training, etc.?

We need a few programs to go back and do an analysis and give us a figure so that we can get an average in project for all programs the cost. Jack Buckhorn suggested that we start with some of the known factors like the notices. The number of apprentices that you have to put through a training program, the cost of a trainer. Etc.

Commissioner Larry Hopkins stated that he attempted to come up with an Analysis/projection for his program. He stated that the initial cost was about \$10,000 which was to actually develop the course. Once you look at the average class size is how we did it. We also looked at the cost of instructors. We were able to come up with a figure of roughly \$7.00 a person. This was an estimated of in house cost. With researching this we found it to be a challenge to separate But this was just a estimate and there were a lot of factors and questions if there was a cost at all.

Comments were received by the public.
