Updates:

It is with deep sadness that we announce the passing of Linda Knox, a retired Apprenticeship Consultant and former Deputy Labor Commissioner, due to a sudden illness. Linda was based in our San Francisco and Oakland offices and served as the lead consultant for many building and construction trades programs in the Bay Area. As someone who had the pleasure of working with Linda at the Labor Commissioner's office and DAS, I can attest that she was a dedicated professional who loved apprenticeship and was committed to protecting California's hardworking labor force. Linda's passing is a great loss to our community.

On a more positive note, I am pleased to announce that the Apprenticeship Innovation Fund (AIF) application period is now open. I encourage all IACA programs to apply for these funds. For more information, please visit https://www.dir.ca.gov/DAS/Grants/Apprenticeship-Innovation-Funding.html. The AIF funding is available to support registered apprentices throughout calendar year 2022. It provides up to \$3,500 per apprentice in full or pro rata if the apprentice was registered during 2022, and an additional \$1,000 per apprentice who graduated from an IACA apprenticeship program during that time frame. Additionally, our IACA programs may be eligible for AIF Training Support through a local educational agency at \$8.82 per hour for RSI. Please note that this fund cannot be applied for if the program is already receiving RSI Prop 98 funding (Montoya Funds) from the California Community Colleges' Chancellor's Office.

I also want to update you on my recent testimony at the Senate's Budget Subcommittee for Labor regarding DAS funding. I testified to the unprecedented funding in AIF and the Youth Apprenticeship Fund (YAF). DAS is slated to receive \$40 million in AIF over the next two fiscal years. This is a reduction of \$20 million to offset the budget deficit we are facing this year. The YAF fund currently remains untouched. We currently have \$20 million this year for grant investment, and \$45 million over the next two fiscal years. This funding will continue to grow our apprenticeship programs and the apprentices it serves to create a skilled and trained workforce for today and tomorrow.

Federal Grants

Apprenticeship System (CAS) database. This funding allows DAS to better capture and represent demographic data across all workforce sectors and provide requested reports to IACA and its members that were not readily available before the recent enhancements to the DAS CAS database system. The new reporting system went live on the DAS website in October 2021 and has been considered a great success by the apprenticeship community as a whole. In July 2021, the U.S. Department of Labor awarded the Division of Apprenticeship Standards (DAS) with the State Apprenticeship Expansion, Equity and Innovation (SAEEI) grant to create apprenticeship pathways within the local workforce ecosystem. This January 16, 2022, DAS released the grant and is Soliciting for Proposals (SFP) from Regional Local Workforce Development Boards and Apprenticeship Program Sponsors to develop new apprenticeship programs or expand on existing apprenticeship programs that work to create opportunities for underserved communities. The grant focuses on creating equitable registered apprenticeship programs for women, veterans, justice-involved, youth, people with disabilities, communities of color and unemployed individuals who were impacted by COVID-19. The grant funding amounts to approximately \$7.3 million to fund multiple grants not to exceed \$4,800 per apprentice, ranging from \$240,000 to \$2,500,000. On May 4, 2022 the DAS was pleased to announce that six successful grantee applicants were awarded the SAEEI Grant. The awards range from \$240,000 to \$2,000,000. The SAEEI applicants awarded are listed on our website. DAS has provided the contracts to our grantees and has executed four contracts and continues to work with our grantees on the remaining contracts. DAS expects to have any remaining contracts executed within the 2nd quarter of 2023. DAS staff continues to meet with our grantees and provide assistance.

The active apprentices numbered 20,023 / 89,844

New registrations and reinstatements numbered **2,815 / 8,368** for the quarter.

Minorities represented 77.9% / 71.0% of all active apprentices.

Active women apprentices numbered **5,435** / **7,899**, which is **27.1%** / **8.8%** of all active apprentices.

There are currently **1,436 / 13,261 veterans** active, **246 / 1,327** of which registered and **126 / 910** completed in 2023.

Program Evaluations January 1, 2023 through March 31, 2023

Since January 1, 2023, there were zero (0) program evaluations opened and twelve (12) evaluations have been completed. Thirty twenty eight (28) program evaluations are in progress and there are two (2) programs with corrective action needed (two (2) opened in 2020). DAS consultants are monitoring these programs to ensure their recommendations are completed.

DAS will continue to send new evaluation notification letters one year following the creation of a new program or substantial expansion of an existing program. To ensure high-quality apprenticeship administration, consultants will assist apprenticeship programs with correcting the deficiencies found in order to close their evaluations/reviews.
