#### Updates:

I would like to introduce Lilian Reaves to our San Diego Legacy Unit. She began her role on September 1, 2023, and we are thrilled to welcome her to our team. Additionally, I'd like to acknowledge the promotions within our DAS team:

• Clio has been promoted to the position of Industrial Relations Representative in our San Diego office in July.

• Sonia Lau, who works in our Oakland office, was promoted to the position of Staff Services Analyst in July.

• In August, Ana Radu achieved a well-deserved promotion to Staff Services Manager I, becoming our first-ever Funding Team Manager in August.

Let's extend a warm welcome to our new team member, Lilian Reaves, and offer our congratulations to these team members who have earned promotions.

Over the past six years, we have witnessed significant legislative changes that have impacted apprenticeship programs, such as the creation of the Interagency Advisory Committee for

Apprenticeship (IACA) through AB 235. Additionally, there has been substantial funding allocated, linking Proposition 98 Related and Supplemental Instruction to the base for-credit community college apportionment. During this time, DAS has evolved from distributing \$3 million annually in CAC grants to administering over \$100 million in Equal Representation in Construction Apprenticeships, Youth Apprenticeships, and the California Apprenticeship Innovation program. While the latter two programs were specifically designated for IACA programs, our CAC programs have gained access to historic investments, including funding from the Employment Training Panel and the California Workforce Development Board.

In the last quarter, Deputy Chief Adele Burnes had the opportunity to travel to Washington D.C. to meet with fellow state and federal apprenticeship leaders. This provided an excellent platform for us to share our strategies for addressing apprenticeship equity, promoting quality job opportunities, and illustrating how apprenticeships can meet the evolving demands of a skilled and trained 21st-century workforce.

On September 29, 2023, I had the privilege of speaking before the Employment Training Panel (ETP) to discuss the Department's efforts in expanding and promoting equity in apprenticeships. This includes our initiatives through the Equal Representation in Construction Apprenticeship grants, the enhancements in Proposition 98 Related & Supplemental Instruction funding, Youth Apprenticeship funding, and the Apprenticeship Innovation Fund. DAS and ETP remain committed to collaborating with workforce entities within the Labor and Workforce Development Agency, ensuring a unified approach to workforce and apprenticeship strategies.

# **Field Office Activities**

Our now five field offices consultants continue to service our existing JACs, UACs and other program sponsors – attend your committee meetings, help on program revisions, annual self-assessments, audit/evaluation report compliance, apprentice disciplinary issues, public works compliance and any other advice and assistance you may need to continue the successful operation of your apprenticeship programs. Numerous committee reassignments continue to take place and we expect more reassignments to equalize workload and services. We are still experiencing retirements in most of our districts we are working to fill all our vacant positions as quickly as possible. We will continue to interview applicants for jobs in multiple offices and are posting more positions, please continue to send/ apply! Please keep encouraging qualified apprenticeship folks to apply! Have patience with the state hiring process, it is slow with many delays beyond our control.

## Apprenticeship Training Fund Check Processing

During the period April 1, 2023 through June 30, 2023:

- **55,688 checks** were reviewed and processed.
- \$ 5,408,662 was sent for deposit.

#### **ERiCA Grant**

The Equal Representation in Construction Apprenticeship (ERiCA) Grant is currently in the review and evaluation phase. The deadline for applications was on January 12, 2023 and all applications were received electronically through the Cal EGrants platform, a platform setup by ETP on Salesforce. DAS has received 35 total applications, with 12 groups applying to both categories of funding: Supportive resources for Childcare and Outreach and Community Building. There were 23 unique lead agencies that have applied for a combined total of \$53M worth of requests. The evaluation is underway to determine how the \$25M will be awarded. DAS announced the <u>ERiCA</u> <u>awardees</u> in March. We have been busy working with our internal departments to finalize the contract approvals and supporting documents for our grantees.

#### Statistics of September 30, 2023 this Council / California total

The active apprentices numbered 71,583 / 93,096

New registrations and reinstatements numbered 7,798 / 10,991 for the quarter.

Minorities represented 69.9% / 71.8% of all active apprentices.

Active women apprentices numbered **2,554 / 8,532**, which is **3.6% / 9.2%** of all active apprentices.

There are currently **13,008** / **14,477 veterans** active, **3,857** / **5,056** of which registered and **1,906** / **2,511** completed in 2023.

#### Program Evaluations July 1, 2023 through September 30, 2023

Since July 1, 2023, DAS did not open any apprenticeship program evaluations. Eleven (11) program evaluations are in progress. There is one (1) program with corrective action needed opened in 2020. DAS consultants are monitoring the program to ensure their recommendations are completed.
