O NET: 47-2141.00

1) Length of Training

Program sponsors shall establish a minimum of a 4 year program of not less than 4800 hours of on-the-job training.

2) Related Supplemental Instruction

The required prescribed courses of related and supplemental instruction (RSI) shall be no less than 520 total program hours. This instruction must include at a minimum the related and supplemental training processes listed in Attachment "A".

3) On-the-Job Training

Skills to be learned are listed in Attachment "B".

4) Competency Testing

All apprentices must pass competency testing prior to receiving any state or industry recognized certifications.

5) Completion Percentages

Program sponsors must have a 38% graduation rate of all apprentices that satisfactorily complete the first year of the program.

6) Revisions

The schedule of revisions to the Painter, Decorator & Paperhanger Industry training criteria shall be in accordance with Section 212.01 of the California Code of Regulations.

Exterior Priming & Painting: Application of primers, intermediate coats and finish coats on exterior substrates.	600
Interior Priming & Painting Application of primers, intermediate coats and finish coats on Interior substrates.	1300
Industrial Painting: Application of Epoxy, Urethane, Polyurethanes on Steel Structures.	150
Prep & Finishing Hardwood: Sanding, sealing, staining and varnishing wood substrates.	300
Color Mixing & Matching: Mixing and Matching existing colors using colorants and tints	300
Texturing Surfaces: Application of various decorative finishes	100
Paperhanging & Wall covering: Preparation and Application of vinyl, Fabric, Foil and Flock Wall coverings	400
Drywall Taping: Basic patch, repair on damaged drywall surfaces prior to primer coating	100
Spray Painting: Application of paints via hydraulic or pneumatic Equipment HVLP*, Conventional, Airless, Air assisted Airless*	400
