18 November 19, 2003 at Santa Barbara, California.


19 All parties were duly notified of this hearing. However,  
20 neither the petitioner nor the respondent appeared at the time and  
21 place set for the hearing. Nadia Masharipov, petitioner's sister,  
22 appeared and was given the opportunity to testify. Having been  
23 sworn in as a witness, Ms. Masharipov testified that whatever  
24 knowledge she had of the dispute between the parties came from  
25 conversations she had with her brother and that she was not a  
26 percipient witness to any transactions between the parties. Since  
27 she could only offer hearsay evidence, the hearing was concluded.  
28 Based on petitioner's failure to appear at the hearing and

1 prosecute his claim, this petition is hereby DISMISSED.
