Subject Matter of Regulations: Sexual Violence and Harassment Prevention Training for Property Service Workers

TITLE 8, CALIFORNIA CODE OF REGULATIONS New Sections 13820 - 13822

NOTICE IS HEREBY GIVEN that the Labor Commissioner, Chief of the Division of Labor Standards Enforcement, Department of Industrial Relations, pursuant to the authority vested in her by Labor Code section 1422, and in accordance with Government Code section 11346.8(c), proposes to modify the text of the following proposed regulation within new Subchapter 13 of existing Chapter 6 of Division 1, of Title 8, California Code of Regulations, regarding Sexual Violence and Harassment Prevention Training for Property Service Workers:

Section 13820(f) Definition of "Trainers"

This further modification is in response to written comments regarding the proposed regulations received during the first 15-day public comment period that ended December 10, 2019.

SUMMARY OF PROPOSED TEXT CHANGES

Section 13820:

• <u>Subsection (f)</u> is modified to address a concern regarding clarity raised by commenters. Specifically, commenters noted that the statute is specific in stating that the Department of Industrial Relations will establish an internet website listing to indicate whether there are qualified peer trainers available to provide the mandated trainings. Commenters stated that the definition of "trainers" in the regulation should be equally explicit that the determination of availability is to be made by this website listing and not by an individual covered employer's own knowledge. The proposed modification reiterates the explicit mandate in the statute for purposes of clarity.
