ACCIDENT INVESTIGATIONS:

On January 2, 2018, an accident occurred on an amusement ride known as Starship 2000 (C17704), owned and operated by Midway of Fun, Inc. At the time of the accident, the ride was located at the Global Winter Wonderland, 1111 Story Road in San Diego, California. A female patron tripped on the steps while exiting the ride and broke her leg. As a result of the investigation, the owner/operator lowered the entrance/exit stairway to comply with the manufacturer's requirements and retrained the employees responsible for assembling and inspecting the ride.

On August 18, 2018, an accident occurred on an amusement ride known as 14' Ferris Wheel (C17331), owned and operated by Special Event Attractions. At the time of the accident, the ride was located at 48160 Pachanga Road in Temecula, California. Two female child patrons received minor head injuries from contacting the ride basket when it became inverted due to a mechanical problem. As a result of the investigation, the owner/operator removed makeshift swing locks intended to assist in transporting the ride from one location to another. In addition, the operators were retrained in operational procedures.

On October 21, 2018, an accident occurred on an amusement ride know as Mobile Zip Line (C19908), owned and operated by Rouse Rentals. At the time of the accident, the ride was located at 2453 Hancock Street in Alameda, California. A male patron sustained a broken arm, chipped tooth, concussion, and internal bleeding from a fall from the zip line when the ride attendant failed to properly connect the patron's harness to the zip line. As a result of the investigation, the owner/operator retrained the ride operator, purchased the correct harnesses, and updated the operational procedures to include a redundant verification of patron connections to the ride.

INSPECTIONS:

The following table lists owner/operators that operated portable amusement rides in the State of California, the number of rides inspected for each owner/operator, the number of annual and temporary permits issued, and the number of rides reinspected during the 2018 operating season.

After an inspection of a portable amusement ride that is found to comply with all applicable regulations, the Division issues an annual operating permit.

When an inspector observes a violation deemed non-critical to the safe operation of a portable amusement ride but requiring corrective action, the Division issues a temporary operating permit expiring on an assigned date within 30 days after issuance.

When an inspector observes a critical violation, no permit is issued.

A ride may be reinspected throughout the year and permitted accordingly.
