What is Cal/OSHA?

The Division of Occupational Safety and Health, also known as Cal/OSHA, protects and improves the safety and health of workers in California. It does this by setting and enforcing standards and providing outreach, education and assistance to both workers and employers.

Communications and Outreach

One of Cal/OSHA's goals is to build partnerships and share important information with workers. For this purpose, Cal/OSHA has the Alliance Program and the Outreach Coordination Program. Through education and information, these programs increase employers' and employees' understanding and commitment to workplace safety and health.

Alliance Program

Cal/OSHA establishes Alliance Agreements with groups committed to worker safety and health to prevent workplace injuries, illnesses, and fatalities. Participants benefit by sharing resources to raise worker awareness and employer knowledge of safety and health hazards through outreach activities and training, with the participation of both employers and employees. These activities help to raise awareness and knowledge of safety and health hazards in the workplace.

Outreach Coordination Program

The Outreach Coordination Program includes bilingual team members who engage with worker organizations to reach high-risk, vulnerable employee populations.

This program provides outreach to organized labor workers, non-unionized workers, community-based organizations, non-English speaking workers, migrant workers, and more. This program includes training sessions, workshops, seminars, speeches, and information booths. All activities are conducted in Spanish and English and cover various safety and health-related topics.

Bilingual staff are trained to provide information on workplace health and safety and workers' rights. Bilingual outreach efforts include: heat illness prevention; wildfire smoke protections; labor rights caravans in coordination with community-based organizations; monthly in-person

presentations at the Mexican Consulates throughout the State and multilingual educational videos that are available on [DIR's YouTube channel](http://www.youtube.com/CaliforniaDIR) (www.youtube.com/CaliforniaDIR), among others.

Some events are presented in collaboration with various state and local agencies, employer groups, workers' compensation insurance carriers, organized worker centers, community-based and faith-based organizations, advocacy groups, and consulates.

Bilingual Community Engagement Liaisons

Cal/OSHA has Bilingual Community Engagement Liaisons who serve as a bridge between various labor organizations and Cal/OSHA. Their goal is to engage and develop partnerships between Cal/OSHA and worker organizations to provide critical information and resources to workers. They actively participate in joint committees and partner with community-based organizations and other state agencies.
