Amalia and Steve,

My first comment regarding your question:

"evaluate the need to develop industry-specific regulations for occupational hazards associated with medical marijuana."

There are certainly atypical hazards in handling concentrated hallucinogenics chemicals that boil at room temperature. Handling extremely volatile terpenes (aroma compounds, NOT THC) that almost instantly trigger serious mental impairment. The smell of cannabis is extremely bioactive. Extracting cannabis concentrates these volatile organic aroma compounds. These volatile organic terpenes dissolve and diffuse straight through most rubbers, including latex and nitrile gloves and most rubber seals. Terpenes disrupt skin and absorb into the bloodstream through skin and trigger hallucinations, anxiety, skin and eye irritation, allergic reaction and more.

It's my opinion that the hallucinogenic aroma of cannabis, that is concentrated by extraction and refining in manufacturing, subjects employees to unique hazards.

I've had such terpenes dissolve through seals, leak out of jars, dissolve through my gloves, and absorb into my skin. The effects are not safe. The mere odor with no THC is very effective at altering your state of consciousness.

If there were industries handling frankincense oleoresin, such as concentrated religious incense, you would have a good example of what you're really dealing with. If you wish to truly understand Cannabis, you'll need to take honest guidance from legitimate scientific and medical community and not trust the psychoactive drug cultivators and dealers to influence or write their own regulations.
