**ECONOMIC IMPACT STATEMENT**

**A. Estimated Private Sector Cost Impacts**

3. **Enter the number of businesses impacted:** DIR estimates 26,674 businesses will be impacted.

**Estimate the number or percentage of total businesses impacted that are small businesses:** Based on the U.S. Census Bureau, there are approximately 4.2 million businesses in California. In addition, the Small Business Advocacy reports 3.6 million small businesses in California. Based on this information, DIR estimates approximately 86 percent are small businesses.

**B. Estimated Costs**

The existing rate structure is comprised of two different hourly inspection fees and a separate permit fee (see table below). The current hourly rate for Shop, Field and Resale Inspection Program fees is \$135.00. The hourly rate for Air Tank, Liquefied Petroleum Gas (L.P.G.) Tank, and Boiler Permit Inspection Program is \$160.00. The Air Tank, LPG Tank and Boiler Permit to Operate Program fee is \$15.00 per permit. This regulatory change will create a single inspection fee of \$150.00 per hour and increase the permit fee to \$45.00.

The Division will almost certainly charge an hourly inspection fee for as long as the Pressure Vessel Unit is required to inspect and certify pressure vessels. In other words, the impact of this fee regulation is indeterminate in duration, and the \$150 hourly inspection fee and \$45 permit fee will continue until Sections 344, 344.1 and 344.2 are amended in the future. The Division cannot predict what the total statewide costs will be *over the lifetime* of the proposed regulation. However, at a net billing rate of \$15 per hour for Shop, -\$10 per hour for Tank inspections, an average of 22,969 inspection hours per year, and a \$30 increase to permit fees, the Division anticipates a net impact of \$964,000 per year.

- a. What are the initial costs for a small business? What are its annual ongoing costs? For how many years will it incur these costs?

The proposed rulemaking simply increases an already-existing inspection fee. It does not require the purchase of new equipment or training or technology, so will not involve “initial costs” as that term is commonly understood. However, based on the above tables, DIR estimates an impact of \$829,000 to small businesses.

- b. What are the initial costs for a typical business? What are its annual ongoing costs? For how many years will it incur these costs?

As indicated above, the proposed rulemaking does not involve “initial costs”. However, based on the above tables, DIR estimates an impact of \$135,000 per year.
