2 MR. CORTES: Okay. Good morning, everyone. Why don't we  
3 go ahead and get started.

4 Thank you for coming today. My name is John Cortes. I am  
5 an Industrial Relations Counsel for the Division of Workers'  
6 Compensation. This is our noticed public hearing for the  
7 proposed evidence-based updates to the Medical Treatment  
8 Utilization Schedule, also known as the MTUS.

9 The Division is proposing to make evidence-based updates  
10 to the MTUS by adopting the latest published version of the  
11 American College of Occupational and Environmental Medicine's,  
12 or ACOEM's, Hip and Groin Disorders Guideline.

13 There is a sign-in sheet and copies of the Notice of the  
14 Proposed Regulations on the desk near the door where most of  
15 you entered this morning. That desk is to my right and from  
16 your perspective to your left. Please make sure you sign the  
17 sign-in sheet and indicate if you wish to testify today.

18 Now, I'd like to take a moment to introduce the other DWC  
19 staff member with me today, and that is to my right is Maureen  
20 Gray, the Division's Regulations Coordinator. Our hearing  
21 reporter today is Wendy Pun.

22 If you wish to be notified of any subsequent changes or of  
23 the final adaptation of the MTUS evidence-based updates, please  
24 provide your complete name and mailing address on our hearing  
25 registration attendance sheet located at the sign-in table.

1 Any notice of the changes and the final notice to the  
2 evidence-based updates to the MTUS will be sent to everyone who  
3 requests that information.

4 The purpose of this hearing today is to receive comments  
5 on the proposed amendments to our regulations, and as always,  
6 we welcome any comments you have about them. Please note, we  
7 will not question, respond to, or discuss anyone's comments,  
8 although we may ask for clarification or ask you to elaborate  
9 further on any points that you are presenting. All of your  
10 comments, both given verbally here today and those submitted in  
11 writing, will be considered in determining what revisions, if  
12 any, we make to the proposed regulations. Please restrict the  
13 subjects of your comments to the proposed regulations.

14 Now, it's obviously not full here today. We've had  
15 regulations -- proposed regulations where this entire  
16 auditorium was full. But since it's not full today, we will  
17 give you or allow you to speak without the normal three-minute  
18 time limit.

19 I will call the name of those who have indicated they wish  
20 to testify today, and I apologize in advance if I mispronounce  
21 anyone's name. When you come up to testify, please first give  
22 your business card to Ms. Gray. And if you have any written  
23 testimony that you would like to submit to accompany your  
24 verbal testimony, please give that to Ms. Gray as well.

25 So all testimony today will be taken down by the hearing

1 reporter. Once everyone on this list has had a chance to  
2 testify, I will check to see if anyone new has come in who  
3 wants to testify or if anybody else has additional comments.  
4 This hearing will continue as long as there are people present  
5 who wish to comment on the proposed regulations, but it will  
6 close at 5:00 o'clock this afternoon. And I obviously don't  
7 think it's going to last that long. If the hearing continues  
8 into the lunch hour, we will take at least an hour break.

9 Finally, all written comments can be given to Ms. Gray if  
10 you have them with you today, or the DWC will accept written  
11 comments by hand delivery up to 5:00 o'clock this afternoon in  
12 the Division's office located on the 18th floor of this  
13 building. Please give them to our receptionist and also  
14 indicate that it's public comment that you wish to submit.

15 The DWC will also accept all written comments by fax, and  
16 the following number is -- or at the following number, and that  
17 is at (510)286-0657. Or if you wish to e-mail it, the address  
18 is dwcrules@dir.ca.gov. Now, all written comments submitted by  
19 fax or by e-mail will be accepted until midnight tonight, so  
20 you have plenty of time to submit that.

21 So with that, let me look at the sign-in sheet and call  
22 the first name. I have already actually looked at it, and I  
23 don't see anyone here who wishes to testify. Are you sure?  
24 Anyone?
