**Order of the Administrative Director of the
Division of Workers' Compensation
(OMFS Update for Hospital Outpatient Departments and Ambulatory Surgical
Center Services - Effective July 1, 2019)**

Pursuant to Labor Code section 5307.1(g)(2), the Administrative Director of the Division of Workers' Compensation orders that the Hospital Outpatient Departments and Ambulatory Surgical Centers Fee schedule portion of the Official Medical Fee Schedule contained in title 8, California Code of Regulations, section 9789.39, is adjusted to conform to changes in the Medicare system, effective for services rendered on or after July 1, 2019. The update includes changes identified in Center for Medicare and Medicaid Services Change Request (CR) number 11318 (May 24, 2019), Transmittal R4313CP.

This Order adopts changes to the OMFS for the Hospital Outpatient Departments and Ambulatory Surgical Centers services to conform to the following Medicare changes:
