**Determination:**

A Request for Independent Bill Review (IBR) was assigned to MAXIMUS Federal Services on 06/13/2014, by the Administrative Director of the California Division of Workers' Compensation pursuant to California Labor Code section 4603.6. MAXIMUS Federal Services has determined that the **Claims Administrator's determination is reversed. The Claims Administrator is required to reimburse you the IBR fee of \$335.00 and the amount found owing of \$89.41, for a total of \$424.41.**

**Pertinent Records and Other Appropriate Information Relevant to the Determination Reviewed**

## Analysis and Findings:

Based on review of the case file the following is noted:

- **ISSUE IN DISPUTE: Provider dissatisfied with reimbursement of billed codes 82055, 82145, 82205, 80299-59, 82520, 80299-59, 83840, 83925-59, 83986 & 81002**
- Provider was reimbursed \$51.08 and is seeking additional reimbursement of \$205.11.
- Claims Administrator denied the billed CPT codes 82055, 82145, 82205, 80299-59, 82520, 80299-59, 83840, 83925-59, 83986 & 81002 indicating the following on the Explanation of Review (EOR): "The charge for this procedure exceeds the Fee Schedule Allowance" and "Charge exceeds Fee Schedule/maximum allowable or contracted/legislated fee arrangement."
- The Provider submitted a copy of the laboratory test results and Provider's Clinical Laboratory license. The submitted toxicology results report a quantitative measure of each drug screened (Amphetamine, Barbiturates, Benzodiazepine, Cannabinoids, Cocaine Metabolites, Ecstasy, Methadone Metabolite, Opiates, Oxycodone, PCP, Tricyclic). Due to the complexity of the toxicology test performed, the levels tracked and results obtained the billed procedure codes 82145, 82205, 80299-59, 82520, 80299-59, 83840 & 83925-59 shall be paid in accordance with HCPCS code G0431. The HCPCS code G0431 is reported with only one unit of service regardless of the number of drugs screened. The testing described by G0431 includes all CLIA high complexity urine drug screen testing as well as any less complex urine drug screen testing performed at the same patient encounter.
- The description of HCPCS code G0431 is "Drug screen, qualitative; multiple drug classes by high complexity test method (e.g. immunoassay, enzyme assay), per patient encounter."
- The drug screen services provided were of high complexity test method. The HCPCS code G0431 criteria has been met based on the documentation submitted by the Provider.
- The billed procedure code CPT 83986, 82055 and 81002 are not considered part of the drug panel and should be paid separately. The description of CPT 83986 is "pH; body fluid, not otherwise specified." The description of CPT 81002 is " Urinalysis, by dip stick or tablet reagent for bilirubin, glucose, hemoglobin, ketones, leukocytes, nitrite, pH, protein, specific gravity, urobilinogen, any number of these constituents; non-automated, without microscopy ."
- The description of CPT 82055 is " Alcohol any specimen except breath."
- PPO Contract was received and a 5% discount is to be applied.
  
- **DETERMINATION OF ISSUE IN DISPUTE: Based on the documentation submitted, additional reimbursement of \$89.41 is to be made to the Provider based on the Official Medical Fee Schedule for HCPCS code G0431 and CPT codes 81002, 83986 & 82055.**

**Determination: Reversed**

MAXIMUS Federal Services, as the Independent Bill Review Organization, has determined the Claims Administrator owes the Provider additional reimbursement. The Claims Administrator is required to reimburse the Provider for the IBR application fee (**\$335.00**) and the OMFS amount for HCPCS code G0431 and CPT codes 83986, 81002 and 82055 (\$89.41) for a total of \$424.40.

***The Claims Administrator is required to reimburse the provider \$424.40 within 45 days of date on this notice per section 4603.2 (2a). This decision constitutes the final determination of the Division of Workers' Compensation Administrative Director, is binding on all parties, and is not subject to further appeal except as specified in Labor Code section 4603.6(f).***
