MAXIMUS Federal Services has completed the Independent Bill Review (“IBR”) of the above Workers’ Compensation case. This letter provides you with the IBR Final Determination and explains how the determination was made.

Final Determination: OVERTURN. MAXIMUS Federal Services has determined that additional reimbursement is warranted. The Claims Administrator’s determination is reversed and the Claim Administrator owes the Provider additional reimbursement of \$195.00 for the review cost and \$200.64 in additional reimbursement for a total of \$395.64. A detailed explanation of the decision is provided later in this letter.

The Claim Administrator is required to reimburse the Provider a total of **\$395.64** within 45 days of the date on this letter per section 4603.2 (2a) of the California Labor Code. The determination of MAXIMUS Federal Services and its expert reviewer is deemed to be the Final Determination of the Administrative Director of the Division of Workers’ Compensation. This determination is binding on all parties. In certain limited circumstances, you can appeal the Final Determination. Appeals must be filed with the Workers’ Compensation Appeals Board within 20 days from the date of this letter. For more information on appealing the final determination, please see California Labor Code Section 4603.6(f).

HOW THE IBR FINAL DETERMINATION WAS MADE

MAXIMUS Federal Services Chief Coding Specialist reviewed the case file and researched pertinent coding and billing standards to reach a determination. In some cases a physician reviewer was employed to review the clinical aspects of the care to help make a determination. He/she has no affiliation with the employer, employee, providers or the claims administrator. The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/services.

ANALYSIS AND FINDING

Based on review of the case file the following is noted:

- **ISSUE IN DISPUTE: Provider seeking \$267.52 in additional remuneration for J3490 (NCD 38779-0731-04, 38779-0524-04, 49452-2147-02, 18860-0720-10) provided to Injured Worker for dates of service 05/12, 05/21, 06/09, & 6/30/2015.**
- EOR's reflect the following 2015 reimbursements:
 - DOS 05/12, \$781.62
 - DOS 05/21, \$781.63
 - DOS 06/09 Documentation not submitted for IBR.
 - DOS 06/30 \$781.63
- Opportunity to Dispute communicated to Claims Administrator on 10/19/2015, response received indicated payment for total services performed and does not indicate line item charges or reimbursement rates.
- Contractual Agreement Not Submitted for IBR.
- Invoices submitted reflect the following:
 - DOS 05/12/2015 Document Paid Cost = \$848.48
 - DOS 05/21/2015 Document Paid Cost = \$848.48
 - DOS 06/09/2015 Document Paid Cost = Documentation not Submitted
 - DOS 06/30/2015 Document Paid Cost = \$848.00
- **Labor Code 5307.1. (e) (2)** Any compounded drug product shall be billed by the compounding pharmacy or dispensing physician at the ingredient level, with each ingredient identified using the applicable National Drug Code (NDC) of the ingredient and the corresponding quantity, and in accordance with regulations adopted by the California State Board of Pharmacy. Ingredients with no NDC shall not be separately reimbursable. The ingredient-level reimbursement shall be equal to 100 percent of the reimbursement allowed by the Medi-Cal payment system and payment shall be based on the sum of the allowable fee for each ingredient plus a dispensing fee equal to the dispensing fee allowed by the Medi-Cal payment systems. If the compounded drug product is dispensed by a physician, the maximum reimbursement shall not exceed 300 percent of documented paid costs, but in no case more than twenty dollars (\$20) above documented paid costs.
- **Based on the aforementioned documentation and guidelines, additional reimbursement is indicated for J3490 (NCD 38779-0731-04, 38779-0524-04, 49452-2147-02, 18860-0720-10) relating to dates of service 05/12, 05/21, & 6/30/2015. Reimbursement is not supported for date of service 06/09/2015.**
