HOW THE IMR FINAL DETERMINATION WAS MADE

He/she has been in active clinical practice for more than five years and is currently working at least 24 hours a week in active practice. The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/Service. He/she is familiar with governing laws and regulations, including the strength of evidence hierarchy that applies to Independent Medical Review determinations.

CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

The injured worker is a 49-year-old female who reported an injury on 01/31/2013. The mechanism of injury was cumulative trauma. Prior therapies included medications and surgical intervention to the right knee, MRIs/x-rays. The documentation that was presented for review was dated 02/2013. There was no more recent documentation submitted. As such, the current medications, prior therapies, other surgical procedures, and recent MRIs or x-rays related to the left knee were not included. There was no Request for Authorization or documented rationale for the request.

IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

Left Knee Arthroscopic Surgery: Upheld

Claims Administrator guideline: Decision based on MTUS ACOEM Chapter 13 Knee Complaints.

MAXIMUS guideline: Decision based on MTUS ACOEM Chapter 13 Knee Complaints
Page(s): 343-345.

Decision rationale: The American College of Occupational and Environmental Medicine Guidelines indicate that surgical considerations are appropriate for patients who have activity limitation for more than 1 month and the failure of exercise programs to increase range of motion and strength of the musculature around the knee. There was a lack of documentation of recent conservative care. There was a lack of documentation of objective findings. Additionally, the request as submitted failed to indicate the specific arthroscopic procedure being requested. Given the above and the lack of information, the request for left knee arthroscopic surgery is not medically necessary.

Associated surgical service: Physical Therapy 3 x 4: Upheld

Claims Administrator guideline: The Claims Administrator did not cite any medical evidence for its decision.
