He/she is familiar with governing laws and regulations, including the strength of evidence hierarchy that applies to Independent Medical Review determinations.

### CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

The injured worker is a 60 year old female, who sustained an industrial injury on April 23, 2015. The injured worker reported sudden onset of left knee pain and pop due to sitting and turning. The injured worker was diagnosed as having left knee sprain, osteoarthritis, dislocation of patella and meniscus tear. Treatment to date has included x-ray, magnetic resonance imaging (MRI), ice and medication. A progress note dated May 14, 2015 provides the injured worker complains of left knee pain and swelling. She reports she has difficulty with activities of daily living (ADL), cooking and driving. Physical exam notes left knee tenderness on palpation, decreased range of motion (ROM) and effusion. Left knee X-ray and magnetic resonance imaging (MRI) were reviewed revealing osteoarthritis and chronically subluxed patella. There is a request for left knee arthroscopy and associated services.

### IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

**Left total knee arthroplasty:** Upheld

**Claims Administrator guideline:** The Claims Administrator did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines, Knee and Leg.

**MAXIMUS guideline:** The Expert Reviewer did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG) knee.

**Decision rationale:** CA MTUS/ACOEM is silent on the issue of total knee replacement. According to the Official Disability Guidelines regarding Knee arthroplasty: Criteria for knee joint replacement which includes conservative care with subjective findings including limited range of motion less than 90 degrees. In addition the patient should have a BMI of less than 35 and be older than 50 years of age. There must also be findings on standing radiographs of significant loss of chondral clear space. In this case, the BMI is not provided. The request is not medically necessary.

**Associated surgical service: Assistant surgeon: Upheld**
