HOW THE IMR FINAL DETERMINATION WAS MADE

He/she has been in active clinical practice for more than five years and is currently working at least 24 hours a week in active practice. The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/Service. He/she is familiar with governing laws and regulations, including the strength of evidence hierarchy that applies to Independent Medical Review determinations.

CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

The injured worker is a 56 year old male, who sustained an industrial injury on 12/30/2004. He reported injury from a fall. The injured worker was diagnosed as having left knee degenerative arthritis. Recent diagnostic studies showed effusion. Treatment to date has included physical therapy, injections, knee bracing and medication management. In a progress note dated 4/23/2015, the injured worker complains of left knee pain. The treating physician is requesting left patello-femoral partial knee arthroplasty, overnight hospital stay, pre-operative history and physical with internal medicine, preoperative labs, electrocardiogram and chest x ray, purchase of crutches, rental of cooling unit for 3 weeks, 18 physical therapy visits and RN for suture removal.

IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

Left patellofem partial knee arthroplasty (robotic assisted): Upheld

Claims Administrator guideline: The Claims Administrator did not cite any medical evidence for its decision.

MAXIMUS guideline: The Expert Reviewer did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG) Knee chapter-knee joint replacement.

Decision rationale: The ODG guidelines report that navigated knee replacement provides few advantages over conventional surgery. PR2s reported gouty arthropathy but not treatment outcomes are reported. The guidelines note that strengthening exercises provide better outcomes but no details of the patient's programs are given. The requested treatment: Left patellofem partial knee arthroplasty, (robotic assisted) is not medically necessary and appropriate.

Overnight inpatient hospital stay: Upheld

Claims Administrator guideline: The Claims Administrator did not cite any medical evidence for its decision.

MAXIMUS guideline: The Expert Reviewer did not cite any medical evidence for its decision.

Decision rationale: Since the primary procedure is not medically necessary, none of the associated services are medically necessary.

Preoperative history and physical with internal medicine: Upheld

Claims Administrator guideline: The Claims Administrator did not cite any medical evidence for its decision.

MAXIMUS guideline: The Expert Reviewer did not cite any medical evidence for its decision.

Decision rationale: Since the primary procedure is not medically necessary, none of the associated services are medically necessary.

Preoperative labs: Upheld

Associated Surgical Service: Eighteen supervised physical therapy sessions, twice a week for nine weeks: Upheld

Claims Administrator guideline: The Claims Administrator did not cite any medical evidence for its decision.

Decision rationale: Since the primary procedure is not medically necessary, none of the associated services are medically necessary.
