A Petition has been filed by Farmers Insurance Exchange ("Farmers") requesting a consolidation and stay of lien claims submitted by Labs for Physicians & Surgeons, Inc., ("LFPS") and Resource Pharmacy, Inc. ("RPI"), to determine whether the liens fall within the provisions of Labor Code Section 4615 such that a stay of the liens is required . After delegation of authority from the Chief Judge, based on the complexity of the claims and issues as set forth therein, and Sections 10396 and 10398 of the California Code of Regulations, this NOTICE OF INTENT TO CONSOLIDATE AND STAY LIENS, DESIGNATION OF MASTER FILE, ORDER OF ASSIGNMENT TO WCJ AND NOTICE OF HEARING is issued.

It is ordered that absent objection PRIOR TO THE STATUS CONERENCE OF 6/21/21, the liens listed in Attachment A will be ordered consolidated to determine whether they fall within an automatic stay of LC 4615 due to criminal charges having been filed against Felix Koltsov. If it is later determined that additional matters should be included in this consolidation, additional orders shall be issued. The purpose of the hearing is to determine whether consolidation and stay of the liens is warranted. The hearing is not to dispute whether the liens arise from the alleged conduct giving rise to the criminal charges, nor for adjudication on the merits of any liens filed by LFPS or RPI.

The above captioned case, SAU8553109, is designated as the Master File. The parties are ordered to use only the designated case number when referencing the consolidated matter. All documents regarding this consolidation shall be filed either by mail to the

Marina Del Rey district office, or by electronic filing by EAMS or JET. Further information regarding alternative document filing during the COVID-19 pandemic may be found on the DWC webpage at www.dir.ca.gov/dwc.
