A Petition has been filed by Kaiser Foundation Hospital, (hereinafter "Kaiser"), requesting a consolidation of liens in the above matter. Lien claimant Med-Legal LLC, (hereinafter "Med-Legal") has objected to the Petition for Consolidation and Stay.

After delegation of authority from the Chief Judge, based on the complexity of the claims and issues as set forth therein, and Cal. Code Regs., tit 8 § 10396, the objection to consolidation is over-ruled. It is ordered that the liens of Med-Legal filed in the cases listed in "Attachment A" to this order are consolidated for determination of the issues raised in the Amended Petition for Consolidation and Stay. All documents regarding this consolidation shall be filed either by mail to the San Bernardino district office, or by electronic filing by EAMS or JET.
