**ORDER OF CONSOLIDATION

A Petition has been filed by Farmers Insurance Exchange, requesting a consolidation of the cases listed in Attachment A for the purpose of discovery into the common issues of law and fact related to whether the listed liens are subject to the automatic stay provision of Labor Code Section 4615(a) due to Moosa Heikali, being an officer, director, or having de facto control of United Medical Radiology Network Inc., and United Medical Imaging Healthcare Inc., (Lien Claimants).

After delegation of authority from the Chief Judge, based on the complexity of the claims and issues as set forth therein, and Section 10396 of the California Code of Regulations, it is ordered that the liens of Lien Claimants identified in Exhibit A are consolidated for the purpose of discovery into the common issues of law and fact related to whether the liens and claims are subject to the automatic stay provision of Labor Code Section 4615(a).

The consolidated liens listed in Attachment A are ordered stayed pending further determination.

The above captioned case, SAU 8277918 is designated as the Master File. If it is later determined that additional matters should be included in this consolidation an additional order shall be issued. All documents regarding this consolidation shall be filed either by JET, e-filing or at the Van Nuys office, unless otherwise ordered. The parties are ordered to use only the Master File case number when referencing the consolidated matter.

WCJ Jeffrey Marrone at the Van Nuys district office is designated as the assigned judge for purposes of this consolidation. Judge Marrone shall have the authority to make all orders as necessary and appropriate in this consolidated matter.

This matter is set for a Status Conference at 10:30 AM on April 23<sup>rd</sup> 2024 before Judge Marrone at 6150 Van Nuys Blvd Ste 110, Van Nuys, CA 91401.
