#### Artificial Tears Background

- Committee previously discussed artificial tears
- Committee wanted to see utilization data and pricing
- 611 potential NDCs for Artificial Tears products were provided to DWC for data capture
- DWC staff pulled data for both pharmacy and physician-dispensed products during the period February 1, 2021 through January 31, 2022
- Only 85 of the 611 NDCs showed utilization during the period
- 22 of the NDCs do not have current effective prices in reference pricing file (marked with a termination date prior to today)

#### **Topical Analgesics**

- Committee asked DWC reach out to ACOEM regarding any research/recommendations regarding the strength of drug ingredients used in "sports creams".
- ACOEM indicated that they have not studied or have any recommendation regarding the individual strengths of the various ingredients in topical analgesic sports creams
- Additionally, the Committee requested updated product utilization data
- To ensure DWC captured as many products as possible to review, NDCs for products from a variety of therapeutic categories were captured.
- 3316 NDCs were provided to DWC for data capture

#### **Topical Analgesics**

- DWC staff pulled data for both pharmacy and physician-dispensed products during the period February 1, 2021 through January 31, 2022
- DWC found 328 NDCs, however only 287 showed an amount paid
- The Zero paid NDCs were excluded from the review
- Irritants / Counter-Irritants account for 151 NDCs
  - Trolamine Salicylate, Local Anesthetics, Other provided as additional info
- Data such as package size and unit price were pulled from pricing extract provided by Medi-Cal through their vendor Magellan
- Some of the NDCs do not have current effective prices in reference pricing file
- Unable to verify the ingredient strengths of some products

#### **Potential Recategorization**

- There are concerns that the categorization currently used might be confusing as it differs in some areas to what prescribers may be use to
- For discussion purposes, the MTUS List has been separated into multiple Excel spreadsheets, roughly grouped into similar therapeutic classifications
- Separating the drugs will make it easier to review
- The current ACOEM classifications are listed for each drug ingredient with potential new Therapeutic and Pharmacological categories
