WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Respondent Mark M. Adam/Live Well MMA, LLC, dba I Care Pharmacy (Mark Adam) was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about April 19, 2023, Mark Adam's license, certification, or approval to provide health care services was surrendered or revoked by the California Board of Pharmacy, Department of Consumer Affairs; and

WHEREAS, on or about August 28, 2024, the Administrative Director mailed to Mark Adam a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

2 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
3 Regulations, title 8, section 9788.1(d), the written notice advised Mark Adam that the
4 suspension would start thirty (30) calendar days after the date of mailing of written notice,
5 unless Mark Adam submitted a written request for a hearing within ten (10) calendar days
6 of the date of mailing of the notice; and

7 WHEREAS, Mark Adam did not submit a written request for hearing within ten (10)
8 calendar days of the date of mailing of the notice; and

9 WHEREAS, the Administrative Director is required to suspend any physician,
10 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
11 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
12 mailed, unless the physician, practitioner, or provider submits a written request for a
13 hearing within ten (10) calendar days of the date of mail of the notice;

14 **IT IS HEREBY ORDERED** that Respondent Mark Adam is hereby suspended from
15 participating in the workers' compensation system as a physician, practitioner, or provider.
