WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about September 22, 2022, Respondent Karl Bandyan's license, certification, or approval to provide health care services was surrendered or revoked by the California Medical Board, Department of Consumer Affairs; and

WHEREAS, on or about February 22, 2023, the Administrative Director mailed to Karl Bandyan a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Karl Bandyan that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Karl Bandyan submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Karl Bandyan did not submit a written request for hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
