**ORDER OF SUSPENSION**

SCOTT ANTHONY BOWLER,  
Respondent.

10 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to  
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
12 as a physician, practitioner, or provider if the individual has been convicted of any felony or  
13 misdemeanor described in Labor Code section 139.21(a)(1)(A); and

14 WHEREAS, on or about November 4, 2013, Scott Anthony Bowler pled guilty to or was found  
15 guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the  
16 Superior Court of California, County of Riverside; and

17 WHEREAS, on or about January 31, 2017, Scott Anthony Bowler pled guilty to or was found  
18 guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the  
19 Superior Court of California, County of Riverside; and

20 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
21 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
22 as a physician, practitioner, or provider whose license, certification or approval to provide health care  
23 services has been surrendered or revoked; and

24 WHEREAS, on or about September 20, 2017, Scott Anthony Bowler's license, certification or  
25 approval to provide health care services was surrendered or revoked by the California Respiratory Care  
26 Board, Department of Consumer Affairs; and

27 WHEREAS, on or about September 7, 2018, the Administrative Director mailed to Scott  
28 Anthony Bowler a written notice of the right to a hearing regarding the suspension and the procedure to  
follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of

1 Regulations, title 8, section 9788.1; and

2 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
3 title 8, section 9788.1(d), the written notice advised Scott Anthony Bowler that the suspension would  
4 start thirty (30) calendar days after the date of mailing of written notice, unless Scott Anthony Bowler  
5 submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the  
6 notice; and

7 WHEREAS, Scott Anthony Bowler did not submit a written request for hearing within ten (10)  
8 calendar days of the date of mailing of the notice; and

9 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
10 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section  
11 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or  
12 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
13 the notice;

14 **IT IS HEREBY ORDERED** that Scott Anthony Bowler is hereby suspended from participating  
15 in the workers' compensation system as a physician, practitioner, or provider.
