ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating to the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about July 20, 2022, the license, certification, or approval to provide health care services issued to Respondent Cherrelyn Estell aka Cherrelyn Louise Estell aka Cherrelyn Louise-Higgins aka Cherrelyn Estell-Higgins aka Cherrylyn Higgins (hereafter "Cherrelyn Estell") was surrendered or revoked by the California Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about October 10, 2023, the Administrative Director mailed to Cherrelyn Estell a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Cherrelyn Estell that the suspension would start thirty (30) calendar days after the date of mailing of written notice,

1 unless Cherrelyn Estell submitted a written request for a hearing within ten (10) calendar
2 days of the date of mailing of the notice; and

3 WHEREAS, Cherrelyn Estell did not submit a written request for hearing within ten
4 (10) calendar days of the date of mailing of the notice; and

5 WHEREAS, the Administrative Director is required to suspend any physician,
6 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
7 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
8 mailed, unless the physician, practitioner, or provider submits a written request for a
9 hearing within ten (10) calendar days of the date of mailing of the notice;

10 **IT IS HEREBY ORDERED** that Respondent Cherrelyn Estell is hereby suspended
11 from participating in the workers' compensation system as a physician, practitioner, or
12 provider.
