A. INTRODUCTORY ALLEGATIONS

At all times relevant to this Information:

Defendant and Others

1. Defendant CATHY FERNANDEZ ("defendant FERNANDEZ") was
hired as a substance abuse recovery counselor by Atlantic
Recovery Services, later called Atlantic Health Services ("ARS"),
in or about December 2003. In 2005, defendant FERNANDEZ became a
"regional manager" for ARS. In this capacity, she supervised ARS

1 substance abuse recovery counselors at seven sites, including
2 Boys and Girls Club, Bell Gardens High School, Odyssey, Alliance
3 Huntington Park, Soledad Enrichment Action ("SEA") East Los
4 Angeles, Estrada Courts, and South Central.

5 2. ARS was a private provider of alcohol and drug abuse
6 treatment services, with its business office in Long Beach,
7 California. ARS was certified to provide services under the Drug
8 Medi-Cal program, described below. ARS operated alcohol and drug
9 treatment programs at high schools and middle schools in Los
10 Angeles County, California.

11 The Drug Medi-Cal Program

12 3. The Medi-Cal program ("Medi-Cal") was a health care
13 benefit program, affecting commerce, that provided reimbursement
14 for medically necessary health care services to indigent persons
15 in California. Funding for Medi-Cal was shared between the
16 federal government and the State of California. Medi-Cal was
17 administered by the California Department of Health Care Services
18 ("DHCS").

19 4. The Drug Medi-Cal program was a program within Medi-Cal
20 that paid for medically necessary alcohol and drug treatment to
21 California's Medi-Cal eligible population. DHCS administered the
22 Drug Medi-Cal program by providing funds to the California
23 Department of Alcohol and Drug Programs ("ADP"), which in turn
24 utilized county alcohol and drug programs ("County ADPs"),
25 including the Los Angeles County Department of Public Health,
26 Substance Abuse Prevention and Control, to provide the eligible
27 drug treatment services. The County ADPs entered into contracts
28

1 with private service providers (like ARS) to provide treatment,
2 recovery, and prevention services for eligible patients.

3 5. Medi-Cal covered outpatient substance abuse services
4 only when such services were medically necessary, prescribed by a
5 physician, and provided in accordance with utilization controls
6 and regulatory requirements set forth in Title 22 of the
7 California Code of Regulations ("CCR").

8 6. Among other things, the CCR required that the provider:
9 (1) develop and use criteria and procedures for the admission of
10 beneficiaries to treatment; (2) complete a personal, medical, and
11 substance abuse history for each beneficiary upon admission to
12 treatment; and (3) complete an assessment of the physical
13 condition of the beneficiary within thirty (30) calendar days of
14 the admission to treatment.

15 7. Drug Medi-Cal providers were also required to have a
16 treatment plan for each beneficiary that was (a) completed and
17 signed by the primary counselor assigned to the beneficiary
18 within 30 days of the beneficiary's admission to treatment, and
19 (b) reviewed, approved, and signed by a physician within 15 days
20 of the counselor's signature. Counselors were required to review
21 and sign updated treatment plans at least every 90 days
22 thereafter, and those updated treatment plans had to be signed by
23 a physician or psychologist within 15 days of signature by the
24 counselor.

25 8. To qualify for Drug Medi-Cal reimbursement, outpatient
26 group counseling had to be conducted in groups with no fewer than
27 four and no more than ten patients (only one of whom had to be a
28

1 Medi-Cal beneficiary). "Group counseling" meant face-to-face
2 contacts in which one or more therapists or counselors treat
3 patients at the same time, focusing on the needs of the
4 individuals served.

5 9. To receive payment for substance abuse treatment
6 services provided, Drug Medi-Cal providers submitted claims to
7 the County ADP reporting, among other things, the dates, units,
8 and types of services (e.g., group or individual counseling)
9 provided to each Medi-Cal beneficiary. To constitute one unit of
10 group or individual counseling, the counseling session had to
11 last 90 minutes (1.5 hours).

12 10. To support its claims for payment, each Drug Medi-Cal
13 provider was required to establish and maintain for at least
14 three years an individual patient record for each beneficiary
15 containing the following documentation: evidence that the
16 beneficiary met the admission criteria for Drug Medi-Cal
17 services; treatment plans; progress notes; evidence that the
18 beneficiary received counseling; justification for continuing
19 services; discharge summary; evidence of compliance with
20 requirements for the specific treatment service; and records
21 substantiating the services for which claims for payment were
22 submitted.

23 B. THE SCHEME TO DEFRAUD

24 11. From in or about 2005, and continuing through
25 approximately mid-April 2013, in Los Angeles County, within the
26 Central District of California, and elsewhere, defendant
27 FERNANDEZ, together with others known and unknown to the United
28

1 States Attorney, knowingly, willfully, and with intent to
2 defraud, executed and attempted to execute a scheme and artifice:
3 (a) to defraud a health care benefit program, namely Medi-Cal, as
4 to material matters in connection with the delivery of and
5 payment for health care benefits, items, and services; and (b) to
6 obtain money from Medi-Cal by means of material false and
7 fraudulent pretenses and representations and the concealment of
8 material facts in connection with the delivery of and payment for
9 health care benefits, items, and services.

10 C. THE MANNER AND MEANS OF THE SCHEME

11 12. The fraudulent scheme operated, in substance, in the
12 following manner:

13 a. Defendant FERNANDEZ would direct the counselors
14 she supervised to enroll students in the ARS substance abuse
15 counseling program even if they had used drugs or alcohol only
16 occasionally or even just once.

17 b. Defendant FERNANDEZ would direct the counselors
18 she supervised to collect student signatures on sign-in sheets
19 for group counseling sessions that the students did not in fact
20 attend.

21 c. Defendant FERNANDEZ would direct the counselors
22 she supervised to collect no more than ten student signatures on
23 one sign-in sheet, even if the students would be attending the
24 same group counseling session.

25 d. Defendant FERNANDEZ would direct the counselors
26 she supervised to prepare Progress Notes and Update Logs that
27 would falsely show that the students in the counselors' caseloads
28

1 had attended 90 minute face-to-face counseling sessions five days
2 each week, knowing that the students had not attended counseling
3 sessions that many days, that sessions they did attend were not
4 90 minutes long, that group counseling sessions included more
5 than ten students, and that the sessions otherwise did not meet
6 the requirements for Medi-Cal reimbursement.

7 e. Defendant FERNANDEZ would direct the counselors
8 she supervised to falsify times on Update Logs and Progress Notes
9 to make it appear that the students on each sign-in sheet were
10 attending group counseling sessions at different times with no
11 more than ten students at the same time.

12 f. Defendant FERNANDEZ would direct the counselors
13 she supervised to submit the false Update Logs to ARS for Medi-
14 Cal billing purposes and to maintain the Progress Notes in the
15 students' files as documentation supporting those claims.

16 g. Defendant FERNANDEZ would direct the counselors
17 she supervised not to "cut and paste" the Progress Notes (which,
18 among other things, purported to recite what students had said
19 during counseling sessions), but to make them appear different
20 for each student.

21 h. Defendant FERNANDEZ would direct the counselors
22 she supervised to use defendant FERNANDEZ's name on Progress
23 Notes and Update Logs to falsely show that defendant FERNANDEZ
24 had substituted for absent counselors and conducted 90 minute
25 face-to-face counseling sessions that she did not in fact
26 conduct.

1 i. ARS would use the falsified Update Logs created by
2 the counselors to generate false and fraudulent claims, which it
3 submitted to the Drug Medi-Cal program for substance abuse
4 counseling services that defendant FERNANDEZ and the counselors
5 she supervised had not in fact provided and services that did not
6 meet the requirements for Medi-Cal reimbursement.

7 j. Medi-Cal would pay the false and fraudulent claims
8 and ARS would receive reimbursement on those claims from the
9 County ADP.

10 13. As a direct and intended result of defendant
11 FERNANDEZ's participation in the scheme, ARS submitted to the
12 Drug Medi-Cal program false and fraudulent claims totaling
13 approximately \$4,942,426 for counseling services purportedly
14 provided by defendant FERNANDEZ and the counselors she
15 supervised, and Medi-Cal paid approximately \$4,702,288 on those
16 claims.

17 D. EXECUTION OF THE FRAUDULENT SCHEME

18 14. In or about February-April 2012, in Los Angeles County,
19 within the Central District of California, and elsewhere,
20 defendant FERNANDEZ, together with others known and unknown to
21 the United States Attorney, for the purpose of executing and
22 attempting to execute the fraudulent scheme described above,
23 knowingly and willfully caused the County ADP to submit for
24 reimbursement by Medi-Cal a false and fraudulent claim for

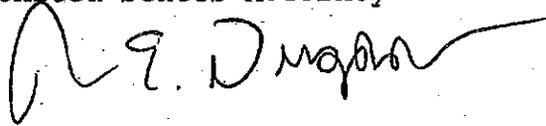
