ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about February 7, 2023, Respondent Christina Garcia aka Christina Garcia Fairchild aka Christina Garci Schimberg Garcia aka Christina Garci Wish's ("Christina Fairchild"), license, certification, or approval to provide health care services was surrendered or revoked by the California Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about July 11, 2023, the Administrative Director mailed to Christina Fairchild a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Christina Fairchild that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Christina Fairchild submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Christina Fairchild did not submit a written request for hearing within ten (10) calendar days of the date of mailing of the notice; and

1 WHEREAS, the Administrative Director is required to suspend any physician,
2 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
3 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,
4 unless the physician, practitioner, or provider submits a written request for a hearing within ten
5 (10) calendar days of the date of mailing of the notice;

6 **IT IS HEREBY ORDERED** that Respondent Christina Fairchild is hereby suspended
7 from participating in the workers' compensation system as a physician, practitioner, or
8 provider.
