WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Philip Jung-Wan Kim that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Philip Jung-Wan Kim submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and
