**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about August 31, 2015, Ohun Kwon pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United States District Court, Central District of California; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Ohun Kwon was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about August 24, 2017, Ohun Kwon's license, certification or approval to provide health care services was surrendered or revoked by the California Board of Chiropractic Examiners, Department of Consumer Affairs; and

1           WHEREAS, on or about August 10, 2018, the Administrative Director mailed to Ohun Kwon a  
2 written notice of the right to a hearing regarding the suspension and the procedure to follow to request a  
3 hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8,  
4 section 9788.1; and


5           WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
6 title 8, section 9788.1(d), the written notice advised Ohun Kwon that the suspension would start thirty  
7 (30) calendar days after the date of mailing of written notice, unless Ohun Kwon submitted a written  
8 request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

9           WHEREAS, Ohun Kwon did not submit a written request for hearing within ten (10) calendar  
10 days of the date of mailing of the notice; and

11           WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
12 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section  
13 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or  
14 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
15 the notice;

16           **IT IS HEREBY ORDERED** that Ohun Kwon is hereby suspended from participating in the  
17 workers' compensation system as a physician, practitioner, or provider.
