WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, Patti Nash did not submit a written request for hearing within ten (10)
calendar days of the date of mailing of the notice; and

5	hearing within ten (10) calendar days of the date of mail of the notice;
6	IT IS HEREBY ORDERED that Respondent Patti Nash is hereby suspended from
7	participating in the workers' compensation system as a physician, practitioner, or provider.
