ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about December 16, 2021, Respondent Julian Omid aka Combiz Omid aka Combiz Julian Omid aka Kambiz Omid aka Kambiz Beniamia Omid aka Ben Omid (hereafter "Julian Omid) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United States District Court, Central District of California; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Julian Omid was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

1 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director
2 to suspend any physician, practitioner, or provider from participating in the workers'
3 compensation system as a physician, practitioner, or provider whose license, certification,
4 or approval to provide health care services has been surrendered or revoked; and

5 WHEREAS, on or about October 26, 2007, Julian Omidi's license, certification, or
6 approval to provide health care services was surrendered or revoked by the Medical Board
7 of California, Department of Consumer Affairs; and

8 WHEREAS, on or about August, 8, 2023, the Administrative Director mailed to Julian
9 Omidi a written notice of the right to a hearing regarding the suspension and the procedure
10 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and
11 California Code of Regulations, title 8, section 9788.1; and

12 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
13 Regulations, title 8, section 9788.1(d), the written notice advised Julian Omidi that the
14 suspension would start thirty (30) calendar days after the date of mailing of written notice,
15 unless Julian Omidi submitted a written request for a hearing within ten (10) calendar days
16 of the date of mailing of the notice; and

17 WHEREAS, Julian Omidi did not submit a written request for hearing within ten (10)
18 calendar days of the date of mailing of the notice; and

19 WHEREAS, the Administrative Director is required to suspend any physician,
20 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
21 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
22 mailed, unless the physician, practitioner, or provider submits a written request for a
23 hearing within ten (10) calendar days of the date of mail of the notice;
