WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about June 23, 2017, Respondent Gordon Allan Onaka's license, certification, or approval to provide health care services was surrendered or revoked by the Medical Board of California, Department of Consumer Affairs; and

WHEREAS, on or about December 20, 2023, the Administrative Director mailed to Gordon Allan Onaka a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Gordon Allan Onaka that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Gordon Allan Onaka submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Gordon Allan Onaka did not submit a written request for hearing within
ten (10) calendar days of the date of mailing of the notice; and

5	hearing within ten (10) calendar days of the date of mail of the notice;
6	IT IS HEREBY ORDERED that Respondent Gordon Allan Onaka is hereby
7	suspended from participating in the workers' compensation system as a physician,
8	practitioner, or provider.
