17	Schmidt for the following reasons.		
18	1. Dr. Schmidt's conviction under Business and Professions section 650 does not meet the		
19	criteria under Labor Code section 139.21(a)(1).		
20	2.	Dr. Schmidt's conviction has been dismiss	sed pursuance to Penal Code section 1203.4.
21	(Exhibit A.)		
22	3. Dr. Schmidt has been reinstated by the Medi-Cal and OIG program. (Exhibit B and C.)		
23	4. Medical Board license remains on probation and addresses this issue. (See Stipulated		
24		Settlement.)	

- 5. Dr. Schmidt's original conviction occurred over December 4, 2020, over two and a half years ago, and therefore the WCAB has waited an unreasonable and unjustified amount of time to bring the suspension against in a way that prejudices the Dr. Schmidt and renders the granting of a claim inequitable.
- 6. To the best of our knowledge, the WCAB previously suspended Dr. Schmidt at the time of his original conviction for a period of three years. This section action is unnecessarily duplicative, punitive, and contrary to the Provider Suspension laws and regulations.
- 7. The Medical Board stipulation also prohibits Dr. Schmidt from treating workers' compensation patients during the terms of his probation. (See Stipulated Settlement, ¶ 4, p. 7.) A suspension is therefore unnecessary, punitive, and redundant.
