This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2009**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

LANDSCAPE/IRRIGATION LABORER

Determination SC-102-X-14-2009-2 is currently in effect and expires on July 31, 2010**.

Effective August 1, 2010, there will be an increase of \$1.50 allocated as follows:

- \$0.25 to Basic Hourly Rate
- \$1.00 to Health and Welfare
- \$0.25 to Pension

Effective August 1, 2011, there will be an increase of \$1.75 allocated as follows:

- \$0.71 to Basic Hourly Rate
- \$1.00 to Health and Welfare
- \$0.04 to Other

There will be no further increases applicable to this determination.

LANDSCAPE HYDRO SEEDER

Determinations SC-102-X-14-2009-2 is currently in effect and expires on July 31, 2010**.

Effective August 1, 2010, there will be an increase of \$1.50 allocated as follows:

- \$0.25 to Basic Hourly Rate
- \$1.00 to Health and Welfare
- \$0.25 to Pension

Effective August 1, 2011, there will be an increase of \$1.75 allocated as follows:

- \$0.71 to Basic Hourly Rate
- \$1.00 to Health and Welfare
- \$0.04 to Other

There will be no further increases applicable to this determination.

LANDSCAPE/IRRIGATION TENDER

Determination SC-102-X-14-2009-2A is currently in effect and expires on July 31, 2010** (please see the important notice dated August 3, 2010).

Effective September 1, 2010, there will be an increase of \$0.41 allocated as follows:

- \$0.31 to Basic Hourly Rate
- \$0.10 to Health and Welfare

Effective August 1, 2011, there will be an increase of \$0.87 to be allocated to wages and/or fringe benefits.

There will be no further increases applicable to this determination.
