Effective December 30, 2012, there will be an increase of \$0.53 to the Basic Hourly Rate and \$0.03 to Vacation & Holiday.

There will be no further increases applicable to this determination.

TREE TRIMMER: 2nd year Climber

Determination C-TT-61-465-5A-2012-1 is currently in effect and expires on December 29, 2012**.

Effective December 30, 2012, there will be an increase of \$0.63 to the Basic Hourly Rate and \$0.05 to Vacation & Holiday.

There will be no further increases applicable to this determination.

TREE TRIMMER: 3rd year Climber

Determination C-TT-61-465-5A-2012-1 is currently in effect and expires on December 29, 2012**.

Effective December 30, 2012, there will be an increase of \$0.70 to the Basic Hourly Rate and \$0.05 to Vacation & Holiday.

There will be no further increases applicable to this determination.

TREE TRIMMER: Thereafter Climber

Determination C-TT-61-465-5A-2012-1 is currently in effect and expires on December 29, 2012**.

Effective December 30, 2012, there will be an increase of \$0.72 to the Basic Hourly Rate and \$0.06 to Vacation & Holiday (Climber after 6 years of service at this level there will be an increase of \$0.72 to the Basic Hourly Rate and \$0.07 to Vacation & Holiday.).

There will be no further increases applicable to this determination.

TRIMMER TRAINEE: Step 1 (0 – 6 MONTHS)

Determination C-TT-61-465-5A-2012-1 is currently in effect and expires on December 29, 2012**.

Effective December 30, 2012, there will be an increase of \$0.44 to the Basic Hourly Rate and \$0.03 to Vacation & Holiday.

There will be no further increases applicable to this determination.

TRIMMER TRAINEE: Step 2 (7 – 18 MONTHS)

Determination C-TT-61-465-5A-2012-1 is currently in effect and expires on December 29, 2012**.

Effective December 30, 2012, there will be an increase of \$0.46 to the Basic Hourly Rate and \$0.03 to Vacation & Holiday (Trimmer Trainee after 1 year of service at this level there will be an increase of \$0.46 to the Basic Hourly Rate and \$0.04 to Vacation & Holiday; Trimmer Trainee after 7 years of service at this level there will be an increase of \$0.46 to the Basic Hourly Rate and \$0.05 to Vacation & Holiday).

There will be no further increases applicable to this determination.

GROUNDMAN

Determination C-TT-61-465-5A-2012-1 is currently in effect and expires on December 29, 2012**.

Effective December 30, 2012, there will be an increase of \$0.41 to the Basic Hourly Rate \$0.02 to Vacation & Holiday (Groundman after 1 year of service at this level there will be an increase of \$0.41 to the Basic Hourly Rate and \$0.03 to Vacation & Holiday; Groundperson after 8 years of service at this level there will be an increase of \$0.41 to the Basic Hourly Rate and \$0.04 to Vacation & Holiday).

There will be no further increases applicable to this determination.
