MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding entered into this 19th day of June, 2014, extends the current Master Labor Agreement between the Wall and Ceiling Alliance (WACA) and the Carpenters 46 Northern California Counties Conference Board through July 31, 2019, and provides the following modifications to the 2011-2015 Northern California Drywall/Lathing Master Labor Agreement:

Term of Agreement:

Agreement shall be effective July 1, 2014 through July 31, 2019.



Modify Article 23 (Holidays) as follows:

The following are nationally recognized holidays covered by this Agreement: New Year's Day, Martin Luther King Day, Presidents' Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the Friday following Thanksgiving Day, and Christmas Day. If any of the above holidays fall on Saturday, the preceding Friday shall be observed as the holiday. If any of the above holidays fall on Sunday, the Monday following shall be observed as the holiday.

The parties have agreed that the following four (4) days of each year will be selected by the Union as designated off/holidays:

2016: Friday, February 12th, Friday, May 27th, Friday, July 1st, Friday, September 2nd.

2017: Friday, February 17th, Friday, May 26th, Monday, July 3rd, Friday, September 1st.

2018: Friday, May 25th, Friday, August 31st, Monday, December 24th, Monday, December 31st.

2019: Friday, February 15th, Friday, May 24th, Friday, July 5th, Friday, August 30th.

In response to your inquiry, the following four (4) days of each year are designated off/collectively bargained holidays pursuant to the above-referenced agreement:


2013: Friday, February 15th, Friday, May 24th, Friday, July 5th, Friday, August 30th

Article 23 (Holidays)

Add new second paragraph:

In honor of those who have served in the Armed Forces of the United States of America, honorably discharged, reserve and active duty members of our Armed Forces shall be permitted by the individual employer to observe Veteran's Day, November 11th. Upon request of the individual employer, members shall provide proof of military service. Veterans choosing to work on Veteran's Day shall be compensated at the appropriate straight time and daily overtime rates.

2007-2012 DRYWALL/LATHING MASTER LABOR AGREEMENT

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding entered into this 19th day of JUNE, 2007, extends the current Master Labor Agreement between the Northern California Drywall Contractors Association (NCDCA) and the Carpenters 46 Northern California Counties Conference Board through July 31, 2012 and provides the following modifications to the 2003-2008 NCDCA/Drywall/Lathing Master Labor Agreement:

Article 23 (Holidays) – Modify as follows:

The following are nationally recognized holidays covered by this Agreement: New Year's Day, Martin Luther King Day, Presidents' Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the Friday following Thanksgiving Day, and Christmas Day. If any of the above holidays fall on Sunday, the Monday following shall be observed as the holiday.

2009: Friday, January 2nd; Friday, February 13th; Friday, May 22nd; Friday, September 4th

2010: Friday, February 12th; Friday, May 28th; Friday, July 2nd; Friday, September 3rd

2011: Friday, February 18th; Friday, May 27th; Friday, July 1st; Friday, September 2nd

2012: Friday, May 25th; Friday, August 31st; Monday, December 24th; Monday, December 31st
