All localities within Alameda, Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, Del Norte, El Dorado, Fresno, Glenn, Humboldt, Kings, Lake, Lassen, Madera, Marin, Mariposa, Mendocino, Merced, Modoc, Monterey, Napa, Nevada, Placer, Plumas, Sacramento, San Benito, San Francisco, San Joaquin, San Mateo, Santa Clara, Santa Cruz, Shasta, Sierra, Siskiyou, Solano, Sonoma, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Yolo, and Yuba Counties.

The predetermined increases for the above named craft applies only to the above referenced determination for work being performed on public works projects with bid advertisement dates on or after March 28, 2019, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

PILE DRIVER (CARPENTER): All Classifications

Determination NC-23-31-11-2019-2 is currently in effect and expires on June 30, 2019**.

Effective July 1, 2019, the predetermined increase of \$3.08 is allocated as follows: \$2.10 to the Basic Hourly Rate, \$0.30 to Pension, \$0.58 to Vacation/Holiday (includes \$0.08 for Work Fees), \$0.05 to Training and \$0.05 to Other.

Effective July 1, 2020: the predetermined increase of \$2.77 is allocated as follows: \$2.15 to the Basic Hourly Rate, \$0.25 to Health & Welfare, \$0.07 to Vacation/Holiday (Work Fees), and \$0.05 to Training.

Effective July 1, 2021: the predetermined increase of \$2.87 is allocated as follows: \$2.20 to the Basic Hourly Rate, \$0.15 to Health & Welfare, \$0.40 to Pension, \$0.07 to Vacation/Holiday (Work Fees), and \$0.05 to Training.

Effective July 1, 2022: there will be an increase of \$2.98 to be allocated as follows: \$2.25 to the Basic Hourly Rate, \$0.25 to Health and Welfare, \$0.25 to Pension, \$0.08 to Vacation/Holiday (Work Fees), and \$0.05 to Training.

There will be no further increases applicable to this determination.
