Class II: \$1.06 to be allocated as follows: \$0.60 to the Basic Hourly Rate and \$0.46 to Health and Welfare.

Class III: \$1.37 to be allocated as follows: \$0.87 to the Basic Hourly Rate, \$0.46 to Health and Welfare and \$0.04 to Pension

Class IV: \$1.50 to be allocated as follows: \$1.00 to the Basic Hourly Rate, \$0.46 to Health and Welfare and \$0.04 to Pension.

Effective September 1, 2020, there will be the following increases:

Class I: \$0.91 to be allocated as follows: \$0.48 to the Basic Hourly Rate and \$0.43 to Health and Welfare

Class II: \$1.09 to be allocated as follows: \$0.66 to the Basic Hourly Rate and \$0.43 to Health and Welfare

Class III: \$1.42 to be allocated as follows: \$0.92 to the Basic Hourly Rate, \$0.43 to Health and Welfare and \$0.07 to Pension

Class IV: \$1.55 to be allocated as follows: \$1.05 to the Basic Hourly Rate, \$0.43 to Health and Welfare and \$0.07 to Pension
