Summary of AB 2043: this bill was signed into law by the Governor on September 28, 2020. The COVID-related bill adds a new section to the Labor Code, section 6725. It passed as an urgency measure, meaning that it went into effect immediately. The new law requires the Division to engage in outreach and educational efforts in the agricultural industry

regarding COVID-19.
