Legislation:

(Review and discuss current legislation which may affect the appeals Board.)

Action: Elizabeth updated the Board on Legislation highlighting three bills.

AB2264 would require employees to obtain heat illness prevention certification from Cal/OSHA and maintain the certification during employment, starting July 1, 2028.
AB3043 would protect artificial stone fabrication and countertop workers from contracting silicosis, a fatal lung disease caused by breathing in tiny bits of silica, a common mineral found in quartz, sand and many other rock types.
AB3106 would require the Standards Board to adopt a standard that ensures workers in California continue to receive their pay and benefits while excluded from the workplace due to testing positive for or displaying symptoms of COVID-19.

Chairperson's Report:

Action: Chair Lowry mentioned in his report that as part of his required training he enrolled in a document remediation course in order to better understand its process.

He also mentioned that the DOSH Advisory Committee meeting is scheduled for March 28, 2024

Board Members Reports:

Action: Board Member Judith Freyman reported on an article in the Sacramento Bee regarding the State employee staffing shortages.

Ms. Freyman also shared information from a newspaper article regarding work safety and recommended two British Medical Journal articles, one on the Impacts of Covid on the 2024 Presidential Election and the other on US Workers during the pandemic.

Board Member Marvin Kropke apologized for the need to cancel the February 7, 2024, Board meeting due to the severe storms in Southern California. He is looking forward to rescheduling the Board meeting to be held in the West Covina office.

Executive Officer's Report:

Action: Acting Executive Officer Patricia Hapgood welcomed Scott Pease, the Board's new Staff Services Manager, and updated the Board on the status of hiring two Administrative Law Judges for the Sacramento office. Interviews concluded yesterday. Interviews for a Senior Legal Typist are underway.
