1. Title 8, Division 1, Chapter 4, Subchapter 4, Construction Safety Orders, Article 32, Section 1742, **Definitions of “Manifold” and “Header”.**

Heard at the August 19, 2010, Public Hearing; adopted on October 21, 2010; filed with the Secretary of State on December 9, 2010; and will become effective on January 8, 2011.

2. Title 8, Division 1, Chapter 4, Subchapter 5, High-Voltage Electrical Safety Orders, Article 17, Section 2813, **Underground Vaults – Headroom Clearance.**

Heard at the September 16, 2010, Public Hearing; adopted on October 21, 2010; filed with the Secretary of State on December 9, 2010; and will become effective on January 8, 2011.

Title 8, Division 1, Chapter 4, Subchapter 4, Construction Safety Orders, Article 22, Section 1648; and Article 25, Sections 1675 and 1678; and Subchapter 7, General Industry Safety Orders, Article 4, Sections 3276, 3277, 3278, 3279 and 3280; Article 5, Section 3287; Article 11, Section 3413; and Article 13, Section 3458.1, **Portable Ladders.**

Heard at the December 17, 2009, Public Hearing; adopted on October 21, 2010; filed with the Secretary of State on December 8, 2010; and will become effective on January 7, 2011.
