After proceedings held in accordance with and pursuant to authority vested in Sections 142, 142.3 and 142.4 of the Labor Code to implement interpret, or make specific, the Occupational Safety and Health Standards Board, by a majority vote, adopted additions, revisions or deletions to the California Code of Regulations as follows:

1. Title 8, Division 1, Chapter 4, Subchapter 7, General Industry Safety Orders, Article 98, Section 4999, **Properly Rigged (Handling Loads).**

Heard at the July 17, 2008, Public Hearing; adopted on December 18, 2008; filed with the Secretary of State on January 28, 2009; and will become effective on February 27, 2009.

2. Title 8, Division 1, Chapter 4, Subchapter 7, General Industry Safety Orders, Article 98, Section 4994, **Crane Hoisting-Use of Outriggers, Stabilizers and Other Supports.**

Heard at the November 20, 2008, Public Hearing; adopted on December 18, 2008; filed with the Secretary of State on January 29, 2009; and will become effective on February 28, 2009.
