Subject: Proposed Amendments for Title 8, California Code of Regulations, General Industry Safety Orders, Section 3657 and New Section 3458.2, Date Palm Operations.

You are invited to participate in an advisory committee to be convened by the Occupational Safety and Health Standards Board (Board) staff on the topic of lift truck-mounted engineered platforms used by employees engaged in date palm operations. The advisory committee will consider proposed amendments to Section 3657 and a new Section 3458.2.

On September 14, 2017, the Occupational Safety and Health Standards Board (Board) conditionally granted Petition 565, submitted by Mr. James Dufour, JD, CIH. In its decision, the Board directed staff to convene an advisory committee discussing the necessary safety and health protections to allow employees to perform date palm operations from atop an engineered platform attached to the forks of a lift truck.

The purpose of the advisory committee will be to consider recommended amendments to Title 8, which will best provide for the safe use of lift truck mounted engineered platforms. The advisory committee will be held at the following time and location:
